In addition, the Board of Education received a handout which detailed the First Semester Expulsion Data from 2014-2017 which is attached as Addendum No. 3.

A Board Member asked if a course has been previously cut could it be reinstated. Dr. Livernois explained that any new course concepts would need to go through mediation to see if it

Ms. Kattula asked whether ESL students could take a course to help them assimilate with everyday life skills. The Office of Curriculum and Instruction will look into how to support all of our students and place them in the right courses.

The Board of Education requested a demographic breakdown for our student population. Dr. Livernois suggested that the report be generated after the February 8<sup>th</sup> Supplemental Student Count Day in order to reflect the most accurate data possible.

President Trombley posed a question to Brent Bott, Director of Security and Crisis Management, regarding parents who participate on the Suspension/Expulsion panel and how are they selected. Mr. Bott explained that they are selected on a rotation basis from a list of volunteer parents.

Ms. Jozwik asked if a student could opt out of the assessment process. Mr. Bernia explained that they will work very closely with students to meet the 95% compliance.

President Trombley requested a copy of the 2017-2018 High School Course Guides to review.


