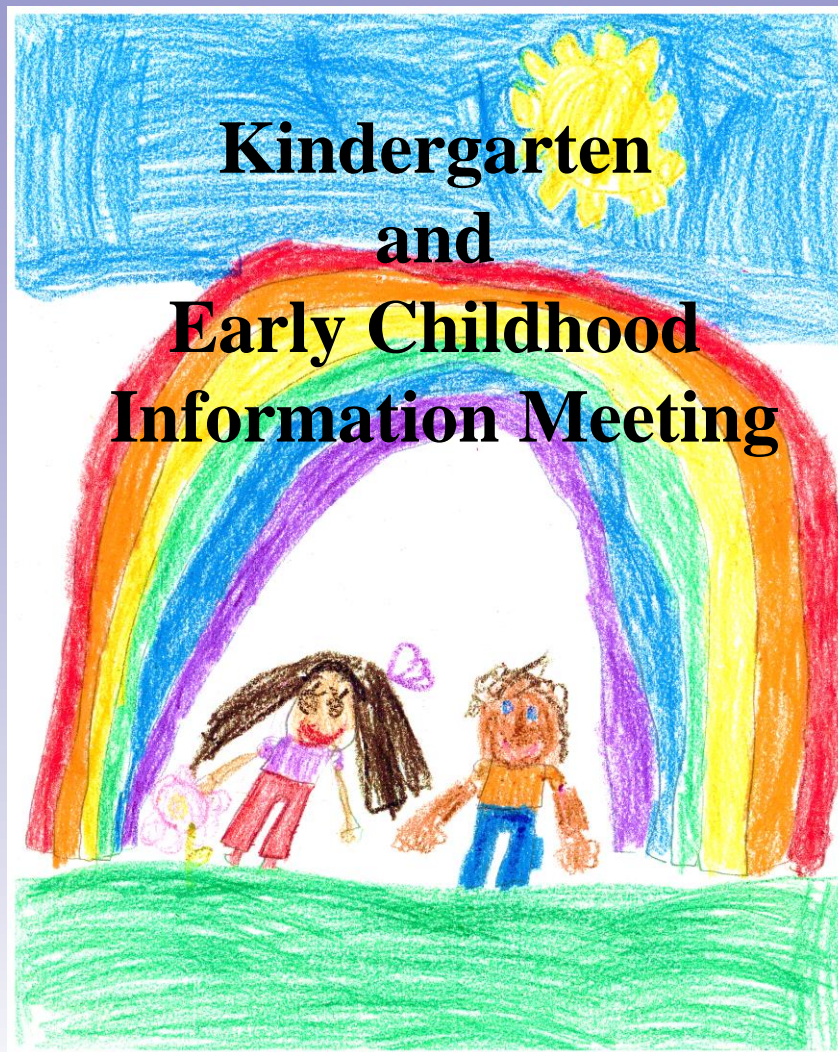

Early Childhood Programs in WCS

- Focus on Kindergarten preparation.

Transitional Kindergarten

- FREE full-day program.
- Five days per week.
- For students who are born between September 1 and December 1, who would benefit from an additional year of growth between preschool and kindergarten, or who have limited early childhood experiences.
- A program that combines academics with critical social and emotional development standards for students not quite ready for traditional kindergarten.

World of Fours

- Must meet income eligibility guidelines and be a Milomb County resident to qualify.
- Half day and full day programs available.
- Must be 4 years old on or before September 1.
- Applications will be on-line in the spring.

Tuition-Based Preschool

- 30 week program.
- For students who will be 3 years of age on or before September 1. Class meets 2 days per week for 2 hours.
- For students who will be 4 years of age on or before September 1. Class meets 4 days per week for 3 hours.

Early Childhood Special Education

- Special Education preschool program for children ages 3-6 with a current IEP.
- Offers half-day programs and one full day program.
- Classes taught by a certified special education teacher with one paraprofessional per classroom.
- Skills taught include: communication, behavior, training, fine motor, gross motor, and preschool academics individualized to the student.

BEFORE & AFTER SCHOOL LATCHKEY

- Latchkey registration begins August 1st. Register online at www.wcskids.net.
- Students must be enrolled in WCS grades TK-5 to attend before-school and after-school Latchkey at their home school.
- Before-school Latchkey is designed for families who need child care before school. Latchkey is available beginning at 6:45 a.m. at each elementary building. The cost for attending before-school Latchkey is \$5.00* per day for each student who attends.
- After-school Latchkey is designed for families who need child care from the time school dismisses until 6:00 p.m. The cost for attending after-school Latchkey is \$7.00* per day for each child who attends. Latchkey is also available on 12 days for a cost of \$15.00 per day for each child who attends.
- Discounts for families with multiple children are not available.
- Parents are responsible for providing transportation to their registered before and after school Latchkey site.
- *Costs for attending may be subject to increase; program availability based on sufficient enrollment.

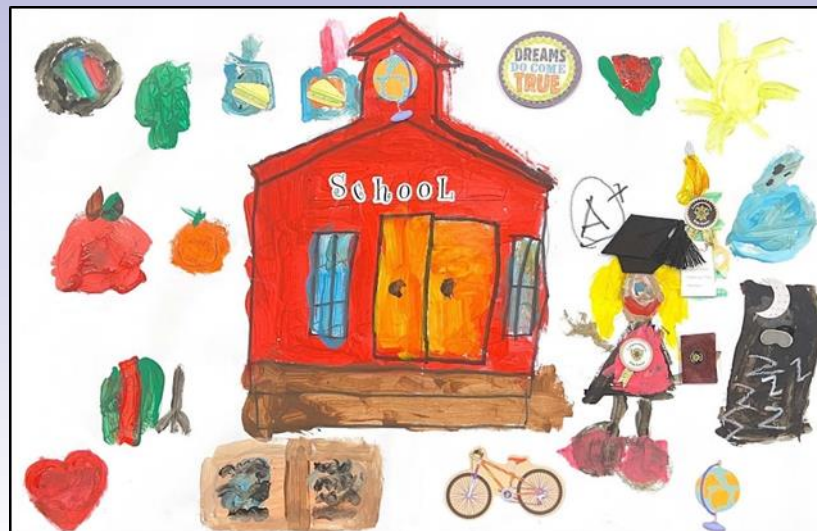

Kindergarten Waiver Request

According to Michigan Law (MCL 380.1147), if a child residing in Warren Consolidated Schools is not five years of age on September 1, 2023 but will be five years of age not later than December 1, 2023, the parent or legal guardian of that child may enroll the child in kindergarten or transitional kindergarten for the 2023-2024 school year if the parent or legal guardian notifies the school district in writing, that he or she intends to enroll the child in kindergarten or transitional kindergarten.

A school district that receives this written notification may make a recommendation to the parent or legal guardian as to whether the child is not ready to enroll in kindergarten due to the child's age or other factors. Regardless of the district recommendation, the parent or legal guardian retains the sole discretion to determine whether or not to enroll the child in kindergarten or transitional kindergarten if the student is five years of age not later than December 1, 2023.
